
**EXPLANATION OF TAX RATE COMPARISONS:**

2025/2026 Tax Rates are based on property assessments. The **2025** Village of Sullivan assessment is \$77,401,800 (90% of fair market value). The tax rates are obtained from the tax levies, which the different taxing jurisdictions certify to the Village.

## **REQUEST OF SULLIVAN VOLUNTEER FIRE DEPARTMENT AND WESTERN LAKES FIRE DISTRICT**

Please make sure your house number is displayed in a location that can be clearly seen 24 hours a day from the road.

Every day the fire siren goes off at noon.  
The 1<sup>st</sup> Wednesday of every month at 11:00am is a tornado warning practice siren.

### **WINTER REGULATIONS**

Per Village Ordinance, **Sec 453-20(a)**, there is no parking on Village streets from Nov 1 through Apr 1 between the hours of 2:30am - 6:00am. If violated, your vehicle will be ticketed and/or towed.

Per Village Ordinance, **Sec 399-7**, the owner, occupant, or person in charge of any property that abuts any sidewalk shall keep sidewalk clear of snow and ice. Sidewalks need to be cleared within 24 hours from the time the snow ceases to accumulate. Any person(s), who violates the provisions of these Sections, shall be subject to a penalty of the cost for the Village DPW to clear the sidewalk. **Do not put snow in the road.**

**ALL DOGS** five (5) months old and older **MUST BE LICENSED NO LATER THAN APRIL 1, 2026**. Licenses may be obtained at the same time you pay for your 2025 taxes. A separate check will be required for the dog license made payable to: Village of Sullivan.
